WHEREAS, HGC procured through Small Value Procurement, the Engagement of a Research Service Provider to Conduct the HGC Customer Satisfaction Survey and has accepted a Proposal by the Supplier for those services in the sum of TWO HUNDRED FORTY THOUSAND PESOS (Php 240,000.00) hereinafter called the "Contract Price".

WHEREAS, in consideration of the payments to be made by HGC to the Supplier as hereinafter mentioned, the Supplier hereby covenants with HGC to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

- b) the Terms of Reference;
- c) the Notice of Award dated ______, 2016; and
- d) the Notice to Proceed dated ______, 2016.

WHEREAS, words and expressions in this Agreement shall have the same meanings as respectively assigned to them in the Conditions of Contract referred to.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree to the following terms and conditions:

- 1. WORK SCOPE AND DELIVERABLES: The Supplier is bound to provide the following services and to deliver the same within the period agreed upon under this Contract:
 - a) develop a workplan in the conduct of customer satisfaction survey;
 - b) draft a survey questionnaire based on guide questions provided;
 - c) finalize survey questionnaire with approval from HGC;
 - d) administer survey questionnaire and conduct interviews;
 - e) process data and analyze results;
 - f) submit initial results including data files;
 - g) discuss survey results with HGC Management; and
 - h) submit final report in both electronic and hard copies.
